

**ORDINANCE NO. 1320-2021**

**AMENDING ORDINANCES RELATING TO AND/OR ESTABLISHING FEES AND/OR FINES FOR ALCOHOLIC BEVERAGES, ANIMALS, COURT, PARKS, RECREATION, AND CULTURAL AFFAIRS, PLANNING, ZONING, AND DEVELOPMENT, PUBLIC SAFETY, STREET AND PUBLIC WORKS, STORMWATER MANAGEMENT, TRANSPORTATION, AND OTHER MISCELLANEOUS FEES AND/OR FINES AND ESTABLISHING A CITY SCHEDULE OF REGULAR FEES THAT CAN BE MODIFIED BY RESOLUTION OF THE CITY COUNCIL.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TAHLEQUAH, OKLAHOMA, THAT THE PROVISIONS OF THIS ORDINANCE SHALL BECOME AND BE MADE PART OF THE CODE OF ORDINANCES OF THE CITY OF TAHLEQUAH, OKLAHOMA AND CORRESPONDINGLY AMEND WHERE APPROPRIATE:**

- **PART 12 PLANNING, ZONING AND DEVELOPMENT;**
- **CHAPTER 2 FIRE DEPARTMENT AND SERVICES, OF PART 13 PUBLIC SAFETY;**
- **CHAPTER 2 USE AND OBSTRUCTION OF STREETS AND SIDEWALKS, OF PART 14 STREET AND PUBLIC WORKS;**
- **CHAPTER 2 AIRPORT TIE-DOWN USE REGULATIONS, OF PART 16 TRANSPORTATION; AND**
- **CHAPTER 4 CONSTRUCTION SITE STORMWATER RUN OFF CONTROLS, OF PART 18 STORMWATER MANAGEMENT,**

**OF THE CODE OF ORDINANCES OF THE CITY OF TAHLEQUAH, OKLAHOMA, AND THE SECTIONS OF THIS ORDINANCE MAY BE RE-NUMBERED TO ACCOMPLISH THIS INTENTION.**

**SECTION 2.** On an annual basis the Mayor and/or City Administrator shall review the current Schedule of Regular Fees as part of the budget reconciliation process and may make recommended adjustments as deemed necessary and present said updated Schedule of Regular Fees to the City Council for consideration and/or approval by Resolution.

**SECTION 3.** The provisions of this Ordinance and the City's collection of the new and/or updated fees as expressed in the Schedule of Regular Fees referenced herein shall become effective on and after July 1, 2021, and remain in effect in perpetuity, or until lawfully repealed and/or altered.

**SECTION 4.** All ordinances or parts hereof which are inconsistent with this Ordinance are repealed upon the effective date of this Ordinance.
